You must have a CA Sellers Permit to sell anything at Hops in Humboldt. If you can not furnish a valid number by August 20th your Application will be disregarded.

- There is a \$100 charge to sell your food at Hops in Humboldt.
- Set-up for food vendors can start as early as 8:00 a.m. but must be complete by 11a.m.
- There is only one type of major food per vendor booth allowed at Hops in Humboldt. Example (If you are doing Tri-Tip Sandwiches, you are the only one at the event to have that on the menu to avoid any competition and too many of the same types of food). Side dishes such as fries, chips and drinks do not count as a major menu category and several vendors may have these items available. Please specify the type of food you want to do. You will be contacted if your requested food type has been pre assigned and given other available options. The first completed and approved application received gets the food spot.
- Once approved you have 10 days to get a temporary food permit from the Humboldt

County Environmental Health Dept. or we may give up your spot to another vendor. If your group is serious we expect a full commitment from you to come that day and fill the spot we have guaranteed exclusivity for you.

- Please do not pack up and leave until the event is finished.
- You must provide your own tables, tent, chairs, panels, electricity and/or shade.
- You must mail in your check with a completed form in time for us to check your sellers permit number No later than August 20th
- You will be contacted after August 27th with space assignment. Once assigned a space you may not switch your number due to the volume of other vendors and limited space. If you have a preference or need special accommodations indicate them in the special requests section and someone will contact you. Do NOT wait until the day of the event as we will not accommodate at that point.
- Typical space is 10' x 10' If you need more room tell us in the special requests space. You will be directly next to another vendor so the front of your booth will be the only area exposed to foot traffic. If you need a larger space or isles on the side of your booth you must indicate that in the special request area and you will be charged accordingly.
- **Please note that there are NO animals allowed at this event.** - Sorry –
- **Hops in Humboldt is a 21+ ONLY event. Children and babies are not allowed per our ABC license. Sorry for any inconvenience this may cause but there are NO exceptions.**
 - Vendors are allowed to purchase up to 5 tasting glasses at a discounted rate of \$20.00 each. You must indicate how many glasses you would like on this form and send the check in with your application. You will have to pay full ticket price if you do not pre-order/pre-pay with your application. All persons will have to show ID at the gate to receive their wrist bands and glasses regardless of pre-sale status.
